**Junior:** Soldiers under 18 and still in training and Army Cadets. - **£Nil**

**Temporary:** Regular and Reserve (incl FTRS) personnel of any service who are not already ASA members in another category. Specific temporary membership for 1 month only for access to ASA training and events - **£20**
